## **GAL0121 SALLY GROSS**

# Gay and Lesbian Memory in Action (GALA)

Dates: extant dates: 1955-2014, bulk dates: 1993-2013.

**Size**: the collection is contained in 36 folders contained in 9 archival boxes and one box of memorabilia.

**Restrictions**: the following files are restricted A3, A8. Researchers are requested to fill in a confidentiality agreement with GALA for access to these files.

**Source**: gift of Sally Gross's brother, Ray Schmidt-Gross, March 2014, and Jennifer Williams, May 2014.

**Summary:** This collection consists of documents from the personal belongings of Sally Gross donated to GALA on her death in 2014 by her brother.

**Biographical notes**: Sally Gross was born intersexed on 22<sup>nd</sup> August 1953 and raised as a boy, Selwyn. In 1976 Gross converted to Catholicism and in 1977 moved to Israel, in political exile for work done against the Apartheid regime. Selwyn was ordained a priest in 1987, having studied Philosophy and Theology at Oxford University. In 1994, after undergoing medical tests to confirm Gross' intersex status, she made the decision to change her name to Sally and live as a woman. Subsequently Rome excused from her vows since it was impossible for a woman to be an ordained priest. She returned to South Africa where she worked for the Department of Land Affairs, and for the Department of Human Rights. She started an organization called Intersex South Africa which aimed at supporting other intersex people, and was an advocate for the rights of intersex people. She made the documentary "The Third Sex".

The collection reflects her transition from living as a man to living as a woman, her work with the South African government in the Human Rights Commission and the Land Reform Commission and her crisis of faith and subsequent interest in Buddhism and Quakerism. Some of her academic writing is also included. Sally died in Cape Town on the 14<sup>th</sup> February 2014.

## Summary from Journeys of Faith:

Sally Gross was born intersex, with a sexual anatomy that didn't seem to fit the typical definitions of female or male. Born to Jewish parents and raised as a boy (Selwyn) who later converted to Catholicism and was ordained as a Dominican Friar. Through this Gross lived with the inner conflict that she identified as female and eventually underwent medical tests confirming her intersex status and changed her name to Sally.

A lengthy and painful battle with the Catholic Church followed – as a woman, Gross could no longer serve as a priest. Fundamentally, the Church rejected all avenues she proposed for her continued involvement. Despite engaging with other religions, nearing her death, Gross professed to have lost all faith and considered herself an atheist.

**Archival notes**: Sorted by Carol Preston April 2014. The collection was received in two cardboard boxes with no indication of method of arrangement. Therefore the collection has been arranged according to category.

## (A) PERSONAL DOCUMENTS 1993-1997 12 folders (A3 and A8 are restricted)

**A1:** one folder containing doctor's letters and testimonials regarding her sex and a doctor's report, letter from Dr KE Leeson, two doctors letters from Dr Hilton Kaplan regarding her medical condition and medication prior to travelling, two envelops of X-rays.

**A2:** Two folders containing documentation on the name change from Shlomo (Selwyn) Gross to Sally Gross (30th July 1993), a certificate of naturalization as a British citizen as at birth, a letter from the South African Director-General assuring Selwyn Gross that dual citizenship was not jeopardized by being granted a British passport (21<sup>st</sup> October 1991), a copy of Sally Gross' South African passport and four original certificates from the University of Oxford. These are for a Bachelor of Arts in Philosophy and Theology (21<sup>st</sup> May 1988) and Master of Arts (13<sup>th</sup> July 1991). These certificates were reissued to reflect the name Sally Gross in June 1995. Certificate of naturalization 22 August 1953, copy of Oath of Allegiance to Queen Elizabeth 1<sup>st</sup> August 1988 and supporting documentation, application for British passport, South African passport application, hand written notes on British Consular information, abridged South African birth certificate, various testimonials.

**A3:** One folder containing correspondence between Fr Timothy Radcliffe and Sally Gross. Fr Timothy was the Master of the Order of Dominicans in the Catholic Church at the time. He was senior to Sally, and she did not report directly to him, but they had a close personal friendship that transcended Sally's decision to live as a woman and lasted beyond Sally leaving the church. The letters form a rich and intimate documentation of the personal trials that Sally endured, her coming to terms with the decision not only to live as a woman but the understanding that she would not be permitted to work as a priest because of this decision.

29 Feb 1993 letter to Timothy discussing Judaism, her struggles with her identity and details on the advice and counselling she was seeking.

9<sup>th</sup> March 1993 letter from Timothy in response.

26<sup>th</sup> April 1993 letter to Timothy thanking him for his letter and giving him an update of conversations she had had with various counsellors and clergy.

3<sup>rd</sup> December 1993 letter to Timothy telling him of her termination of employment by Lynda, in Jerusalem, requesting advice on employment and her decision to live as 'Sally'.

17<sup>th</sup> March 1994 letter from Timothy telling her about a questionnaire that she would be taking. Attached is a copy of the instructions from John Mills to the other superiors in the clergy as to how to deal with the press.

21<sup>st</sup> March 1994 Letter from Malcolm clearing up misunderstandings.

17<sup>th</sup> April 1994 letter to Timothy outlining her biological status and letting him know that she would not be returning to life at the priory as a man.

24<sup>th</sup> April 1994 Letter to Timothy discussing the dispensation, her willingness but inability to return to the order and other options open to her.

4<sup>th</sup> May 1994 Letter from Timothy giving advice on the options.

25<sup>th</sup> July 1994 Letter from Timothy on self-acceptance.

12<sup>th</sup> August 1994 Letter to Timothy outlining the events and correspondence around her dismissal from the order.

5<sup>th</sup> September 1994 Letter to Sally assuring her that the dispensation was above board and was not a request to renounce vows of celibacy, with a copy of the dispensation attached.

13<sup>th</sup> October 1994 Letter to Timothy dealing with her reaction to the dispensation, Timothy's letter, hostile process of dismissal and recent developments.

10<sup>th</sup> November 1994 Letter to Timothy a follow up on the previous letter, which was written to him officially as the Master of the Order. This letter was written as Timothy's friend also on the dismissal and Sally's personal struggles.

11<sup>th</sup> November 1994 Letter to Sally responding to her letter and discussing the dismissal. 19<sup>th</sup> February 1995 Letter to Timothy outlining her distress and the break from the church, her financial difficulties and her consideration of suicide.

26<sup>th</sup> July 1995 Letter to Timothy outlining her erosion of faith.

28<sup>th</sup> August 1995 Letter to Timothy continuing on the erosion of her faith and stating that she was enclosing an outline of her faith in Jesus. This outline is missing.

8<sup>th</sup> September, The Feast of the Birth of Our Lady, letter from Timothy assuring Sally that those who doubt the validity of her baptism are incorrect.

10<sup>th</sup> September 1995 Letter from Timothy thanking her for the Celtic cross that she sent him.

24<sup>th</sup> February 1996 Letter to Timothy discussing the options open to her, her feelings towards Christianity and urgently asking for help.

Easter Monday letter from Timothy discussing options open to her

6<sup>th</sup> May 1996 Letter to Timothy telling him about her return to Blackfriars and her interest in the Quakers.

19<sup>th</sup> June 1996 Letter to Timothy outlining possibilities for his silence and thanking him for his humanity and friendship.

29<sup>th</sup> June 1996 Letter from Timothy outlining letters he had written seeking assistance for Sally.

18<sup>th</sup> July 1996 Letter to Timothy letting him know that her depression was lifting and discussing options for her.

19<sup>th</sup> August 1996 Letter to Timothy telling him about the tabloids tricking her into giving them information which they published, and how she had warned the church of possibly repercussions.

1<sup>st</sup> September 1996 Letter to Timothy continuing with events and her feelings of betrayal and distress after the tabloid incident.

31<sup>st</sup> October 1996 Letter from Timothy responding to the letters on the tabloid incident. 20<sup>th</sup> January 1997 Letter to Timothy telling him about her time in Holland.

7<sup>th</sup> February 1997 Letter from Timothy responding to her previous letter.

**A4:** one folder containing postcards on Buddhism, personal notes on self-help, meditation, notes and workshop questionnaires taken while on retreats, and lists of terminology from various websites on spirituality.

**A5:** one folder of official personal documents: five South African passports, four Israeli passports, one Israeli unidentified document, originals and copies of her father and mothers' birth certificates plus their wills, American Go Association membership card, one South African Identity Document, one brown zipped folder containing what may be Israeli Identity Documents but could be Israeli medical documentation and diplomas and certificates of various courses attended; communication re. returning to South Africa (1994 and 1998 – with Frene Ginwala).

A6: One folder of Sally's natal chart and psychological horoscope

**A7:** Miscellaneous letters and cards, including library card, bookmarks, an address book and a hand written letter wrapped in a paper binding marked "Sally" and sealed.

**A8:** Three folders that came in one lever arch file. The order in which documents were found has been retained, and have been numbered accordingly from the front of the file to the back (1-83). These documents contain newspaper clippings and correspondence regarding a complaint that Sally laid against a newspaper that exposed her as a priest that was living as a man and now as a woman.

den dowel stick with embroidered image of Buddha; cream shawl with tassels and Hebrew inscription; white Parliament of South Africa shirt – 10 Years of Democracy Civil Guard of Honour; dark blue cap with "Commission on Restitution of Land Rights" logo; two small painted Buddhist masks – both damaged and repaired presumably by Sally; metal spiked candle holder with candle; coffee cup with "Sally" inscription; brass bell and matching brass ornament; wooden crucifix (this was especially beloved by Sally since the carving of Christ appeared to her to be intersex – information from Jennifer Williams and appears in one of Sally's letters).
