It's a wonderful movie with Robert Morse, who plays a young man who starts a new job in the mailroom and by evening he is the CEO of the company. Well, my ascent to the Presidency was not quite that swift, but still, for a girl who didn't know TGSF from a cable TV Channel less than a year ago, I admit I have come very far. I realize that many of you don't really know me (even though you may have voted for me). So in the next few months I will do my best to try and get to know all of you a little better. I will be writing a monthly report as your President but I am also going to continue my "Hart to Heart" column because I think that will be important for me to sometimes address you as your sister, not just as your President.

The first order of business is to pay tribute to the old ExCom. Thank you Rachel Hill, Stephanie Ann Blythe, Ally Grillo and Gia Luisa. I am so proud of and grateful to many of you for all of your efforts on behalf of your sisters. (You'll notice, by the way, that one name is conspicuous by her absence. I'll get to her in a minute.)

And congratulations and welcome to your new ExCom members: Vice President Susan Laird (moving up from Secretary), Treasurer Brooke Miller, Secretary Rys McCusker, Education Co-Chairs Kara Flynn (who is, I am happy to say, staying on for another term) and Kelly Anne Marsh, Outreach Co-Chairs Kalani Makaanani (also continuing) and Marla Selby, and Social Co-Chairs Aiyanna Eveningstar (another holdover) and Roxxanne Taylor. I sincerely appreciate you stepping up to the plate to continue the vital work we must carry out.

Which brings me to Rachael Janelle. There isn't enough room in this *Channel* or hours in the day for me to appropriately describe how I feel about this wonderful lady who has touched my heart and who has made me a better woman. I would not be here if it weren't for her love and kindness towards me. If you have read my past columns in the *Channel*, you know how I feel about her. Every time I think about what she has meant to me I want to cry as I am doing now (which is not good since I am typing this at work) and I want to celebrate because I am happier than I have ever been due, in large part, to what she has meant to me and to others. Rachael's tireless and selfless dedication and energy is a testament to what TGSF is and should be about. We should take our cue from her and look at her as a model for how we should conduct ourselves as members of this ExCom and this organization. I am going to miss Rachael as part of the ExCom but I will have her as a trusted adviser and more importantly, as a life-long friend. Rachael, you believed in me since Day 1 and I will forever love you for that.

And now that we reflected on our past, we must look to the future. I wrote some of the words below after the March ExCom meeting, before I had any thoughts about running for President. At that time, I was feeling very unsure about the direction of our organization and whether it would continue to be what it has been. I threw down the words below as a challenge to the new ExCom, regardless of whether I was part of it. However, since I am now leading that ExCom, I believe it is fair to hold myself to the same standards I challenged others to live up to.

I believe that our organization faces five significant challenges.

**The first challenge is that of money.** It is no secret that funds are tight, as they are for virtually every non-profit organization. How do we generate sufficient revenue so that TGSF can continue to do the things that our members expect and need from us? I am going to appoint a fundraising committee, to develop and help implement various strategies.

**The second challenge is that of vision.** This ExCom must develop a coherent agenda with clear goals and objectives. What are we trying to accomplish? Are we a social group, an educational group, a support group, a political group or a hybrid of all of the above. In light of our financial situation, we must evaluate our purpose. Perhaps we no longer can be all things to all people but we must set a direction and move towards it. We cannot lose our focus, which is to make our members feel welcome and safe and loved. Educational events, outreach efforts and socials are important tools in this effort. I am very pleased to see that we have some energetic and enthusiastic people in these positions so I am confident we will meet this challenge.

**The third challenge is that of communication.** How can we communicate to our members our vision? We have used the *Channel* and the socials but are the members getting the message? We may need to look at new ways to articulate the goals of TGSF to members and other interested persons, so that more people feel compelled to join and to participate.

**The fourth challenge is that of involvement.** The strength of an organization lies not in its leaders but in its members. It was stated months ago that there is an overwhelming amount of work to do and very few people to do it. I am putting out a call right now, to our members and friends to get involved. I will be forming subcommittees to look at the Pride Parade, the Cotillion and fundraising, and over the course of this year, I will personally call on several of you to step up and assist. So whether you help build our Pride Parade float, act as a safety monitor, or help plan our Cotillion, our TGSF needs you. Help make it something special. In addition, I am asking all of the ExCom members, myself included, to participate in as many of our events as you can. I strongly urge you to attend each ExCom meeting and to participate in the decision-making. Our members have entrusted us with important work to do and we cannot belie that trust. If we are asking our members to get involved, then we must set an example.

**The fifth challenge is that of unity.** Remember our wonderful Christmas dinner at the Tarragon? What a radiant eruption of TG pride that was! It didn't matter if we were part of TGSF, RGA, DVG or another group. It didn't matter if we were CD, TG, TS, FTM or something else. *We worked together to make it happen!* I recognize that we have differences in our community regarding purpose and function. We are individuals and individuals disagree. But to make that happen, we had to work together to achieve a common goal and as a result, we had a very successful event. And the Cotillion. Although it was a TGSF event, many helped out that together, whether they were part of TGSF or not. We all worked together to do something we believed in. We need to do more of that. We need to look at more ways in which we can work together for the common good, which is, lest we forget, those who need us the most.

I plan to make the fourth and fifth challenges the cornerstones of my administration. And here's why.

For the last few months, I have been answering the hotline. Every day I become convinced that there is a growing need for what we do. I have answered calls from coast to coast. I recently answered a call from a young woman in Florida who happened upon our number "Where can I go?" she asked. She had no place else to turn to. It is incumbent upon each of us to ensure that the calls from that girl and the hundreds, perhaps thousands, like her, do not go unanswered. In last month's *Channel*, Rachel Hill mentioned my passion. She's right. The girls who call the hotline are my passion. Those of you who have just stepped into the light are my passion. Those of you who believe that we can and will make a difference are my passion.

I would like each of you to join me as we walk that road, hand in hand, ready to meet the challenges I have outlined. I am confident that we will.

## TGSF ExCom MEETING MINUTES

Meeting called to order at 2:15 p.m. Present: Rachael Janelle, Rachel Hill, Susan Laird, Kara Flynn and Stephanie Ann Blythe. Guests: Roshelle Cunning, Marla, Brooke Jansen and Kelly Marsh.

### Presidents Report:

Request for approval of the minutes for March 2003. Seconded and approved. Pride Parade: The beer booth will not be available, but the information booth has been applied for. Discussion of certificates of appreciation for the year's work at the end of the month meeting at the Blue Muse. Introduction of Roxy who will be the new president as she is running unopposed.

### Vice President's Report

Work on the pride float is being discussed but ideas are dependent on the size and type of trailer. Trailer is a low-boy type 45' long X 8' wide. Call for 10 volunteers who will act as safety monitors for the float. They must attend a training class about one hour in duration held at various locations throughout the bay area. Costs associated with the float will be held as low as possible.

### Secretary's Report

Website: Presentation of the suggestion that membership be allowed to choose between viewing The Channel through the website or receiving it my mail. Discussion of dues in relation to the type of viewing is held. Decision is made to wait through the elections to advise membership. Members should be advised that the dues structure has been modified to facilitate the renewal of membership at anytime throughout the year rather than just April or May.

TGSF on Yahoo: Stephanie Ann reports that there has been a problem with "trolls", people who deliberately inflame members of TGSF yahoo. Problem with Gwen and Stephanie having to work more as traffic cops on the group, screening people who sign in. Membership on TGSF Yahoo is probably about 20% actual TGSF members. It is suggested that ExCom study the possibility of moving the TGSF discussion group to our own website and limit participation to actual members of TGSF. Motion to table the issue for further study until May.



### Treasurer

Presentation of financial report to ExCom. \$1670.55 is the current balance in the treasury. Outstanding accounts receivable and accounts payable are listed and discussed. Advertisers who have not paid for their advertisements in The Channel will be removed. Brook Jansen will be the new treasurer as she is also running unopposed. Preparations are made to hand over the job of treasury to her.

### Education

The LGBT center has asked if TGSF would be interested in helping with a planned May 18<sup>th</sup> picnic. TGSF barbecue will be held on May 25<sup>th</sup> at the home of Rachael Janelle. No other events are planned at this time.

### Outreach

No information was available. Elections are to be held at the Blue Muse on Thursday April 25<sup>th</sup> and everyone is encouraged to come say goodbye to the old ExCom and also meet with the winners of the elections.

### New Business

Special Report from President-Elect Roxy Carmichael-Hart Phone Hot line: Presentation of story about someone in serious trouble who called TGSF and received supportive help and caring. This is the mission of this group and often we fail to remember that in spite of our ongoing issues concerning membership, finances, etc. that our existence is a great good for those in need of help.

Introduction of new proposals for the financial future of TGSF. Discussion is held as to the priorities of past due accounts and the raising of future revenues. Cotillion 2004 planning is discussed as well. Possibility of a fund-raising position on ExCom is proposed and discussed. Motion to adjourn. Seconded. Meeting adjourned at 3:40 p.m. Next Meeting to be held on May 4<sup>th</sup>, 2003 at the home of Susan Laird.

Friday I came as all girl and even attended a debriefing meeting with my peer group. No one said a thing either way.

Over the weekend my bliss turned to fear. Huge fear. It really settled in just what I had done. And I had never spoken with HR or my manager about the situation. I was going to be so fired. On Monday I had a lunch already scheduled with the SVP of Premier Banking. I was very concerned that once I had made the leap, I would not go back. Flipping back and forth would look like I was playing games so I was determined to stay girl. I dressed in a woman's business suit and went to lunch. Christy was a bit taken back, but quickly recovered. When she asked me how management was dealing with it, I squeaked out, "I haven't told them". I was in sooooo much trouble.

Tuesday I was to be at another huge sales rally, this time with banking center managers from all over California. These folks I did NOT know. Monday night I finally got through to my boss. I quickly explained my situation and asked for his advice for the next day. He said he did not see any reason for me not to carry forward. I was a bit relieved but still worried about Tuesday.

By the time I arrived at the Concord Hilton, there were hundreds of bank associates everywhere. To my surprise, management plucked me out of the crowd and pulled me aside just to make sure I was doing ok. That made me feel pretty wonderful. I integrated myself back into the crowd and picked up my nametag. At this point I had not changed to my female name so it still had the old one. The highlight of my day was standing in line for the women's room with a nametag showing my male name. I can laugh about it now, but I can't believe I made it through the day.

So the moral of the story is to plan well, but expect some unexpected turns.

It's now been one year now and next week I go back to that same sales rally, again in SF. This time I'm really going to enjoy myself. In Fact there are a few SoCal boys I would like to get to know a little better. Wish me luck!

## BREAST CANCER EMERGENCY FUND DINNER

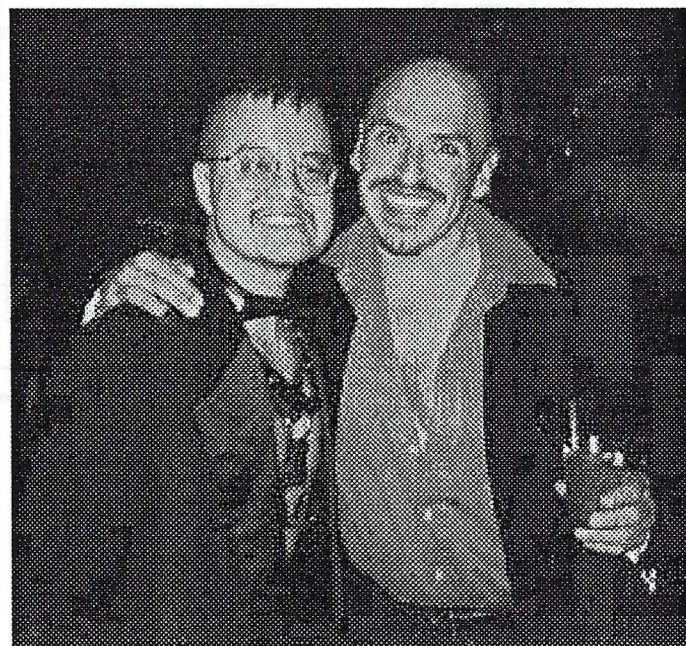
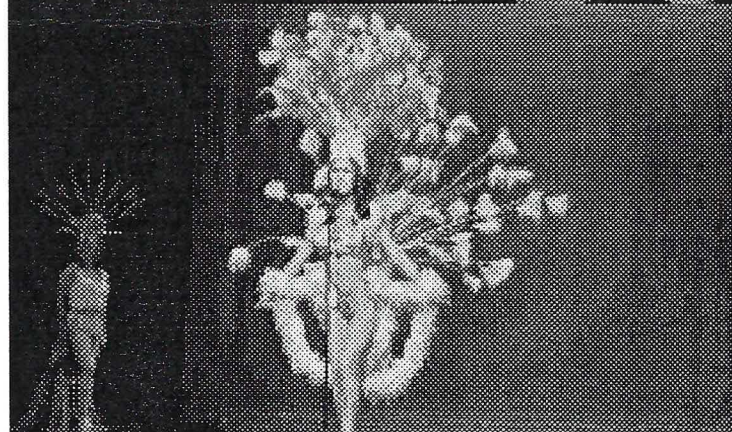

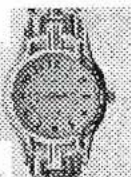

# Heart To Hart with Roxy

Note: I wrote this article back in February before I had an inkling that I would be President. I thought I would share it with you, unedited, so that you would get a sense of what TGSF has meant to me.

## WHAT'S A NICE KID LIKE YOU DOING IN A PLACE LIKE THIS?

Not that this title is particularly relevant to anything, but I have always wanted to use it.

If you are currently looking at this article, chances are that you are a member of TGSF. Or, if you are not a member, you may have picked up the *Channel* at one of our events. If you are a member, then you probably realize that this being April, membership renewal time is just around the corner.

As you consider your renewal or perhaps new membership, I would like you to take a moment and reflect on what membership or participation in TGSF has meant to you. What if there were no TGSF? Would you have been able to walk proudly as a debutante in the Cotillion? Would you have competed for Miss TGSF? Would you have had a joyous Christmas dinner at the Tarragon? Would you have marched in the Pride Parade? And most importantly, would you have met a wonderfully supportive group of friends who have encouraged you and helped you? Perhaps.

Then, again, perhaps not. I know that for me, if there were no TGSF, I would not have had the opportunity to do any of the activities I mentioned above. I know that at best, I may have dressed only occasionally or I might not have gotten out at all. I might have stayed home alone. I might not have been Roxy at all. I just don't know.

But TGSF was here for me, as it has been for many of us. I know the affect that being a member of this organization has had on me. I know that participation in this organization (and RGA and DVG) has given me the strength and the encouragement to move forward. It has given me the confidence to not only be a member of the ExCom, but to also compete for Miss TGSF 2004. It has given me the opportunity to do something I love, which is to write (thank you Ayme). I have grown not only as a woman but also as a person. I find myself to be more loving, more accepting, more compassionate and more tolerant of others. I want to hold my hand out to every girl out there who is alone, afraid or unsure and tell them "Come with us. We will help you." I doubt that any of this could have happened without TGSF in my life. And I know I have said it before but the support network that I have received has been wonderful. I know I would not have received that without TGSF. And this is why I have dedicated myself to doing whatever I can to making sure that TGSF continues to be there for all of us.

I observe how TGSF treats the new girls. Every one is always greeted with a smile and a hug. Every one is made to feel welcome and part of the family. Every one is made to feel as if she belongs. To me, that is the ultimate beauty of this family. It is that love, that acceptance, that support that eases the transition into the person you were meant to be.

As I write this, the ExCom is currently looking at a variety of new membership benefits. You will probably be informed about them long before you read this article. I know that after the holidays, the Cotillion, paying taxes and the general state of the economy, our purses are somewhat empty. But I promise that if you will renew or begin your membership, the benefits will be returned to you several times over.

And maybe the title of my article was relevant after all. Because the "place like this" has allowed me to be me. I can't think of a better purpose than that.

## HOTLINE TO HEAVEN

In my President's report, I noted that sometimes I would need to address you as your sister, not as your President. This is one of those times.

I have heard some people wonder whether we matter. Sometimes, I admit, I have wondered it myself. When I see how few people show up at events, when I see memberships decline, when I see few people stepping up to run for office, I wonder "do we matter?"

As I stated in my President's report, I have been answering the hotline for the last few months. This isn't something that I asked to do; it's something that Rachael Janelle thought I would be good at. I didn't really know what to expect. After a few months, however, I am more convinced that we most assuredly do matter. A lot.

I have taken calls from all over the country. Most are asking about TGSF. Those are the easy ones. Some ask "where can I get hormones", "are there clubs I can go to?", "I need shelter", "I'm afraid for my brother". Those are a little harder. I usually go to my list of references (which is sorely in need of updating) or the Tranny Guide, or other resources of which I am aware and help as best I can. And then, there are the calls such as the one I had last night; the calls that make you numb.

A young woman (my age) called from Kentucky. She was 125 miles from Lexington, no friends in the area, no car, rejected by her parents for whom she moved to be near, afraid to venture out for fear she'd be laughed at, pointed at, or worse, beaten up. Mind you this is someone who had SRS 26 years ago. She was so lonely and so unhappy. She wanted desperately to move back to the Bay Area. As I listened to her story, tears began streaming down my face. I was touched deeply by her pain and her agony as I tried to assure her, through my own tears, that she was not alone and that she mattered to me.

The lady was looking for someone who could give her a line on housing. Although I do not have knowledge of that, I gave her the name of an angel named Tiffany Woods, who I know has done some research. But as the call went on, the lady kept couching her remarks with "if I get back there, I am so depressed". I told her that when she got back her, she should come to TGSF and she would be welcomed and hugged and loved and made to feel as part of the family. And then she said (and I cannot write this without crying), "Now I have a reason to live because when I get back there I know I can see you." After she hung up, I sobbed for 10 minutes before calling my own angel named Rachael Janelle who comforted me. I called the lady back and we talked for another hour about all kinds of things.

The point of this story is that *someone* was at the other end of that phone when she called. *Someone* touched her and cared enough about her to let her know she mattered and was important. *Someone* was there for her when she needed it. Any one of us could have returned that call. The point is that *someone* did.

How many times has one of us felt like she did? How many of us have felt so alone and unhappy that we wondered whether we wanted to go on? How many of us have been in that position? I will bet many, if not most of us. When that happened, weren't we glad that there was a TGSF to which to turn; a TGSF that would hug you and welcome you and love you?

TGSF is more about the fancy dinners and the floats and the tiaras. It's about a community - a very strong community of people who need and are needed. It's about our sisterhood. It's about the place where we can come to where we can feel welcomed and safe and loved. The calls from that lady, and the hundreds like her must NEVER go unanswered.

So, do we matter? Ask the woman in Kentucky.

## TGSF FUTURE

It's been almost 10 years since Jamie emerged and joined TGSF, or ETVC as it was known then. Both have changed in unimaginable ways. When I started, ETVC met at the Chez Mollet. Ginny Knuth's health had begun to fail. We had about 400 members, and each of the Outreach, Social, and Education committees not only had chairpersons, but members. Cindy Martin was the President.

So much has changed. After years as a waif, we now meet at the Blue Muse. Membership has dwindled. We lost Barbara, Ginny, Nancy Ann, and Janis. The world changed too. We went from maybe 50 computer bulletin boards to, as of today, 793,000 indexed web pages on Google. Through many of our efforts, everyone now says GLBT rather than GLB.

I served on the Executive Committee for about 18 months as Secretary, starting in 1994. I have long considered running again for President or Vice President. The biggest issue for me is living 50 miles away - a situation that I am working on changing.

I look at the state of the club and see both possibilities and problems. There are more social, education, and outreach possibilities for TG people than ever before. Much of the TGSF leadership will be turning over soon. I feel TGSF has to change to adapt to the times. Here are some possibilities to consider.

### \*Simplify Things\*

Our membership is smaller and the service mix we now deliver has changed. We should be able to slim down to a simpler Board of Directors. We also need to take a hard look at what our service mix is, and how it integrates with the other agencies in San Francisco.

The TGSF Executive Committee was designed for our mission years ago. Perhaps it can be reorganized to be more efficient and less taxing on its members.

### \*Go Virtual\*

TGSF should conduct its affairs, as much as possible, using telephones, email, and on the web. This will reduce the need to travel as well as open up participation.

The Channel should be produced using a content management system and essentially be a frozen, edited rendition of the electronic presence, printed out.

### \*Have Fun\*

Try to combine business with pleasure. Make sure there is some sort of celebration involved any time we get together. Make it cool to work on TGSF projects and people will want to do exactly that. Our Awards Night should be a big deal. It was in 1994.

### \*Hold the Cotillion Somewhere Else\*

Making any money at all at the Design Center is extremely difficult. Typically we lose \$2000-\$4000. They keep the entire proceeds from the bar and the facility rent is high. This is in contrast to earlier years where we would make \$2000-\$6000 and give a sizeable check to charity. We need to move.

This list is just for starters, and I am sure many other TGSF members have good suggestions. Times have changed and TGSF must as well. Let the discussions begin.

## Beauty Boost

### SKIN 101

This month's column is devoted specifically to the function of skin. There's more to the skin than meets the eye. It's not just a canvas on which to apply makeup and hold in our bones. In fact, it is the largest human organ, and consists of a complex network of hairs, nerves, blood vessels, sweat glands, sebaceous glands, and sensory apparatuses for heat and cold. Collagen gives skin structural support for cells and blood vessels. Elastin gives the skin its elasticity. As we age, both the collagen and elastin weaken, thus causing the skin to lose moisture and resiliency. It is also why changes in our skin are so noticeable, particularly where hormones and acne are concerned.

## The Ask Master

Q Margaret, Queen of All Things Faggoty, I love you. You help keep me sane — or at least comfortably well balanced. But I'm in desperate need of your advice.

Ever since I was 4 years old, I've dressed in women's clothes and wanted to be a girl. Back then, I put on my mother's bras and wore the neighbor girl's clothes during sleepovers. I have the attitude and the entertaining styles. I've got great hips, I can get in better shape and I have the walk down.

Another disadvantage is that I'm 16 years old and in northwestern Virginia. I am completely out of the closet with my aunt and uncles (my guardians), with friends and at school. I am pretty damn popular, which is surprising, considering I live in a conservative military community. I have gotten past those hurdles. Now I really just need help with this drag queen thing. I have a name, an act and all kinds of other stuff picked out, wardrobes and all. I just really need some advice on how to get to where I am going. Please help me; I'm losing my mind!

## Connectivity - Ground Breaking Issue

### MENTAL HEALTH ISSUES AMONG FEMALE-TO-MALE TRANSGENDERED PERSONS ADDRESSED

Nearly a third of female-to-male (FTM) transgender persons have been forced into mental health treatment against their will, according to a new survey released this week by FORGE (For Ourselves: Working Gender Expression) and published in *Connectivity*.

Ninety-six persons — most of them FTMs, along with a sprinkling of SOFFAs (significant others, friends, family and allies) and male-to-female (MTF) transgendered persons — answered the comprehensive, 19-item mental health survey. Available data and analysis covers the prevalence of mental health conditions, the level of severity of those conditions, rates of suicidal ideation and attempts, types of and reasons for mental health treatment, the perceived relationship of transness to mental health conditions, the impact of hormone use on mental health conditions, types of coping strategies used, the extent of mental health insurance coverage, and the extent to which having a co-existing mental health condition influenced therapists' willingness to write a letter allowing the transperson to obtain hormones or surgery.

The survey results are published in a groundbreaking, 56-page double issue of *Connectivity* focusing specifically on the mental health issues, concerns, and coping strategies of FTMs and SOFFAs. The issue also includes:

- First-person articles and poetry about living with trauma, paranoia, other people's "scripts", autoimmune hypothyroid disease, bipolar disorder, and issues youth face in accessing care;
- Articles on the mental health needs of female partners, parents and children of transpeople, those with trauma histories, and those who are going through a gender transition;
- Articles on spiritual, body and energy, and self-esteem approaches to mental health;
- What to look for in a therapist, and a review of what one national mainstream mental health group tells its constituents about "LGBT" mental health needs.

## WE HOLD THESE TRUTHS

Perhaps the gravest problem facing many lesbian, gay, bisexual, transgendered or questioning people is the fear that we are alone. It might seem obvious to the outside observer that there are many people in these situations. However, when you are mired in the midst of a discriminatory situation, there is frequently an overpowering feeling of aloneness. The feeling may not be rational, but the feeling is most certainly real.

Many of us have been treated poorly by our family, our friends, our church or our government. We think that no one knows how we feel. We think that no one knows the problems that we face. We think that no one can help us. We think that no one will support us. We think that no one will stand by us if we tell the truth. Many of us have turned to drugs and alcohol to escape the effects of this treatment. Many of us carry deep emotional scars that require strong medications to provide temporary relief. Some of us have resorted to the ultimate escape of suicide.

What we need most is someone who understands our plight, cares about us and offers support. When we find such a resource, they become a virtual lifeline for us. In recent years, the Internet has provided a growing number of such support resources. Because of anonymity and ease of access, it has become the most effective vehicle for delivering support information. It is an unbelievably powerful force to calm our feelings and help us find hope and support and peace. It is now our primary place for finding lifelines.

This message is an appeal to existing lifelines to become more robust and interconnected. It is also an appeal to encourage potential new lifelines to emerge.

### Additional Documents

We need online access to as many articles, books, brochures, pamphlets, papers and speeches as possible. Any given document might speak the exact words that are needed by a hurting person at a critical time. Providing a brief extract of the contents of a document and grouping like documents in some sort of categorization scheme are also extremely helpful techniques that enable searchers to find what is of greatest value to them.

I have just finished updating my web site to reflect 5 different series of articles:

- We Hold These Truths - Confronting societal and spiritual discrimination
- Planting Loving Seeds - For Christians who feel excluded because of their differences
- The Femme Mirror - Understanding for heterosexual male transvestites
- Spouses & Partners - Helping couples deal with cross-dressing issues
- Our Gender Family - Creating a healthy and unified gender community

Would you review your web site to determine what additional documents might be included and how they might be presented in a more user-friendly manner?

### Enhanced Links

Nearly every web site has a list of links to other related sites. No single site has all of the resources needed by LGBTQ people. However, I believe that all the information we need is stored somewhere on the web. The trick is how to find it. We need to go beyond alphabetical listings of related links. We need to develop strong interconnected ties with each other. Links should include a sentence or two about the contents of the linked site. Links should be grouped into categories so that comparable sites are listed together. Wouldn't it be great if an LGBTQ person could find one site and from there be able to reach every other site through a series of well-defined links?

I have just finished updating my web site to reflect links to 11 categories of support resources:

- Links to Spiritual Support Resources - Churches, ministries, TG Christians, denominational support organizations, reading list and articles
- Links to Social Support Resources - Cross-dresser support groups, professional help, support & informational resources, spouses and children

Would you invest the effort into upgrading the links on your site to bring us all closer together? If you don't currently have a web site, consider starting one even with the most basic information. Some of the finest resources started as very small sites and have grown in value over the years. Whether you are an individual or an organization, you have some information that is of value.

Remember - your actions are critical because these lifelines actually save lives!

## TRANSGENDER SAN FRANCISCAN MAKES HISTORY AS WOMAN OF THE YEAR

It was quite an entrance by anyone's standards. A silence fell over the crowded floor of the state Assembly in Sacramento last week as lawmakers and their staffs slowly realized what they were about to witness. Heads turned as Theresa Sparks nervously made her entrance along a walkway on the Assembly floor, the first transgender woman ever to be honored as an Assembly "Woman of the Year."

As uncomfortable as she was to break down that barrier, it was a journey that the Nob Hill resident was more than happy to take as part of an ongoing battle to raise transgender awareness for people in the mainstream. "After my bio was read, there was no question that I had 400 pairs of eyes on me," Sparks said. "There was an instant where I was uncomfortable but my position is to never be ashamed of who I am. I made it a point to make eye contact with people, on both sides of the aisle."

Sparks, 53, was relieved to see big smiles and thumbs up from various lawmakers, many of whom made it a point after the ceremony to congratulate her on the distinction. But she also saw a few heads quickly turn away as she made eye contact while walking down the hallway, a reaction she has come to expect during the eight years she has lived as a woman.

Sparks never intended to become an activist when she made the decision to shed her life as a husband and father of three, but it's a position she has embraced after becoming more comfortable in her life as a woman. Born and raised in Kansas City, Sparks enjoyed dressing up in women's clothing from a very early age but fought those urges as a young man.

A Vietnam veteran, Sparks got married in 1971 and had three children before he told his wife about his inner turmoil in 1980. Sparks and his wife quickly separated and later divorced. He began a process of intense therapy and an electric shock treatment in an attempt to suppress his desire to live as a woman.

Many counseling sessions and another marriage later, Sparks finally realized the only way he would find inner peace would be to live as a woman. A trial period led to a full-time existence as a woman by 1997 and Sparks traveled to Thailand three years later for sexual reassignment surgery.

She settled in San Francisco in 1997 to blend in easier, increase therapy and find work. She ran up against what she perceived as discrimination when she was turned down for at least 100 jobs during the dot-com boom, despite her background as an environmental services executive.

"I thought with my experience, I would be able to find something really quickly," Sparks said. She eventually found jobs as a taxi driver, a bank teller and a census taker before landing her current job as a financial manager of Good Vibrations, a \$15 million corporation that specializes in sex toys and publishing. She found love along the way, settling into a three-year relationship with a freelance journalist.

Sparks became an activist soon after her move to San Francisco and compiled an extensive resume of causes that resulted in her state assembly honor. Since 1999, she has lobbied the San Francisco Board of Supervisors for transgender rights and medical benefits, chaired a task force that addressed issues of police sensitivity toward transgendered people, organized vigils for transgendered murder victims and founded the Transgendered Political Caucus in 2000 to advise local politicians about transgender issues. She currently serves as co-chair of the Alice B. Toklas LGBT Democratic Club after lobbying the group to have its name include the words "bisexual and transgender."

Her extensive work for transgender causes prompted Mayor Willie Brown to appoint her to the city's Human Rights Commission in early 2001, where she serves as chair of the LGBT advisory committee. "She has a lot of knowledge about gender identity discrimination and was very instrumental in drafting new (sensitivity training) protocols for the police department," said Larry Brinkin, co-manager of the committee.

Sparks also worked extensively on election campaigns for Assemblyman Mark Leno, D-San Francisco, the man who named Sparks the "Woman of the Year" from his district, calling her a trailblazer.

Although Sparks has been recognized for her work in various San Francisco circles, her trip to Sacramento last week was the first time she had left the comfort of her home town to be paraded in front of a slightly more conservative crowd. The anxiety was worth the payoff, she said.

"The community really needs some type of figures or models to look at and to understand that it's OK to do this and to live your life how you feel," Sparks said. "I think role models are very important."

## JAY LENO, NBC FUEL 'DEHUMANIZING' OF TRANSGENDERS

The National Transgender Advocacy Coalition (NTAC) issued a statement today, criticizing the National Broadcast Corporation (NBC) and Tonight Show host Jay Leno today for highly insensitive remarks disguised as humor in his nightly monologue.

Calling it "Prime time dehumanizing of transgenders," the chair of NTAC, Vanessa Edwards Foster, admitted that Leno might not write all of his material for the monologues. "However, he does have final decision over material that he feels is inexcusable," she added. "In this instance, Jay Leno felt it was okay to belittle transsexuals."

Last month, MSNBC hired blatantly homophobic and transphobic talk show host Michael Savage. Savage is a radical conservative who fires potshots at anyone not straight, white male and staunchly conservative. But the recent comments from Leno indicate a mainstream trend of acceptance of insensitivity toward the transgender community.

In his March 31 monologue, Leno, arguably the country's best-known late night talk show host noted a male-to-female transsexual honored in as Woman of the Year in California Assembly District 13 by Assemblyman Mark Leno (D-San Francisco). The talk show host is no relation to the openly gay assemblyman.

In his monologue Jay Leno commented that the California Assembly "awarded a man who had a sex change as its Woman of the Year. When 'he' accepted the award, 'he' said there was a part of 'him' that didn't want to accept it ... but that's gone now."

In a statement, NTAC board chair, Vanessa Edwards Foster said, "In a country where no positive accomplishments of transgenders are ever reported for fear of promoting a "transgendered lifestyle," it's curious that belittling humor of these same people is openly welcomed. Jay Leno's remarks took what was a historic recognition for an accomplished transgender community leader and summarily diminished them with insensitive humor.

"We're a community that's afforded few heroes, and little hope. Destroying what little positive impact our community makes, simply for the purpose of gratuitous laughter, serves to objectify transgenders and crushes individuals' hope.

Foster acknowledged that Leno does not write all of his material. "But he does have the final decision regarding what he uses," she said. "Leno obviously felt it was okay to belittle transsexuals." "Coupled with the bombastic blasts from the Michael Savage show on MSNBC, it is easy to denote a trend of dehumanization being broadcast to the nation from this network. It speaks to transgenders that we're deemed 'different' enough to be fair game for any cheap shots fired at will. For others who take umbrage with such 'different' groups as transgenders, it also leads to a ready detachment of humanity.

"Some of this detachment of humanity was evident at a house party last October in the murder of a transgendered California teenager, Gwen Araujo. Pre-trial testimony of the case showed that 17-year old Araujo was brutally beaten and bludgeoned by four young men. At one point, as she sat battered and bleeding on the murderer's couch, she was ordered to get off of it because she was dirtying it with her blood.

"Even though the teen, a male-to-female transsexual, pleaded to have her life spared, she was beaten with a frying pan, choked, strangled with a rope, and had her head smashed with a shovel. Her killers then drove to a remote area near Lake Tahoe, buried her body in a shallow grave, and then stopped at a fast food restaurant for breakfast. None of the partygoers alerted authorities.

"As Gwen's mother Sylvia Guerrero lamented, they treated Gwen as if she wasn't human. Indeed this was inhuman violence, but it is only the end effect. The cause begins when one is allowed to detach humanity from transgenders and other minority groups. NBC with their choice of programming, and Jay Leno's choice of seemingly harmless humor, implicitly perpetuate this lack of any human quality allowed transgenders.

"We implore NBC, and its parent corporation General Electric, to exhibit more responsible concern in their choice of programming. We also request Jay Leno and his writers on the Tonight Show to practice more responsible awareness in their choice of material, and more sensitivity to the impact that has on the targets of such humor. As one wouldn't make tasteless public commentary about other political, ethnic, religious or even sexual groups with blithe disregard, we simply ask to be provided the same consideration."

## TRANSGENDER RIGHTS BILL APPROVED BY CA ASSEMBLY

Boyce Hinman, Chief Lobbyist of the Lambda Letters Project, expressed his delight that AB 196 was approved by the California Assembly on a preliminary vote of 41 in favor, 34 opposed and 6 abstentions. The opposed and abstention votes may change, but the 41 votes are rock solid. So the bill now goes to the California Senate. AB 196, introduced by Assembly Member Mark Leno (D of San Francisco), would ban employment and housing discrimination against transgendered people in California.

Hinman noted that Lambda Letters has been pushing for this legislation since 1998. It has cosponsored three bills to ban discrimination against transgendered people. The first two bills (AB 2142 introduced in the year 2000, and AB 1649 introduced in 2001) were approved by the Assembly but failed in the Senate.

This year the members and friends of the Lambda Letters Project have delivered over 9,500 letters and E-mails to the Assembly in support of the bill. Hinman vowed that Lambda Letters will continue to deluge the legislature and the governor with letters in support of the bill. He added he is hopeful that, this year, the bill will become law.

The Lambda Letters Project is California's oldest statewide organization lobbying on behalf of the lesbian, gay, bisexual, transgendered, and intersexed community. It helps people write letters to elected officials on these issues and also on HIV/AIDS, issues of concern to people of color, and women's issues. It delivers well over 200,000 such letters each year.

## Federal Appeals Court Says Schools Must Protect Gay Students from Harassment

SAN FRANCISCO - In a case brought by the ACLU of Northern California, the national American Civil Liberties Union and the National Center for Lesbian Rights, the 9th Circuit Court of Appeals issued a historic decision today which holds school officials liable for failing to protect students from anti-gay harassment. The court held that a school must take steps to eliminate harassment when it learns that lesbian, gay and bisexual students are abused at school.

"This decision affirms that in the public schools, all students deserve the same protection from school authorities," said ACLU-NC staff attorney Ann Brick. "This decision is long overdue. Finally, it's clear that schools can no longer stand back and turn a blind eye to the kind of debilitating harassment that so many lesbian, gay and bisexual students face every day," said Kate Kendall, Executive Director for the National Center for Gay & Lesbian Rights. Matt Coles, Director of the Lesbian and Gay Rights Project of the ACLU added, "The court made it very clear that going through the motions is not enough. Schools have to really deal with the problem of anti-gay harassment."

The decision comes in a lawsuit brought on behalf of five high school students in Santa Clara's Morgan Hill Unified School District who charged that school officials refused to take any action to protect the students from ongoing anti-gay harassment. The students, four girls and one boy, were repeatedly abused both physically and verbally. One student was hospitalized after a group of male students shouted "faggot" and other homophobic slurs while hitting and kicking him at a school bus stop in full view of the bus driver.

A female student, Alana Flores, found a pornographic picture taped to her locker. A handwritten note attached to the photo read, "Die, Die, Dyke, bitch, Fuck off. We'll kill you." When Flores sought help from the school and asked for a new locker, the principal said, "Yes, sure, sure, later. You need to go back to class. Don't bring me this trash anymore. This is disgusting."

The case, Flores v. Morgan Hill Unified School District, will now return to the federal district court for trial. The students are represented by James Emery and Jill K. Ginstling, of Keeker & Van Nest, LLP, the ACLU-NC, the National ACLU Lesbian/Gay Rights Project, and the National Center for Lesbian Rights.

## HMO SUES CA OVER SEX REASSIGNMENT ORDER

(Los Angeles, California) One of the largest health care providers in California is suing the state to prevent paying for a transgendered woman's sex reassignment surgery.

Health Net Inc. was ordered by the California Department of Health to provide the woman, identified in court documents only as P.M., with the surgery after the company turned her down.

P.M. appealed to the Department of Health and an administrative law judge agreed with her doctor that the surgery was necessary. That decision was upheld by the Department of Health and Health Net was ordered to proceed with the surgery.

The company is under contract with California to provide health care under the state's Medicaid plan. Health Net suing the state to have the order reversed. The company says sex change operations are not medically necessary.

Brad Kieffer, a spokesman for Health Net, said private health insurers routinely exclude coverage for gender reassignment operations. "Under these circumstances, we think it right and appropriate for us to seek a reconsideration."

A Los Angeles Superior Court judge will decide if the case can go ahead. Until then P.M.'s surgery is on hold.

## TG SUES ASHCROFT

(Washington, D.C.) A transgendered government worker is suing Attorney General John Ashcroft and others for job discrimination.

Tracy Nichole Sturchio who works as a Border Patrol specialist says she is not permitted to wear a dress to work, is denied the use of the women's bathroom and has been subjected to continual sexual harassment and workplace discrimination.

Sturchio has filed a discrimination suit in U.S. District Court in Spokane, Washington. She names Ashcroft, Border Patrol Chief Gustavo De LaVina and Michael Garcia, commissioner of the Immigration and Naturalization Service.

Sturchio has been employed by the Border Patrol since 1991 and has worked at the Spokane office as a telecommunications specialist since July 1998. She has undergone sex reassignment surgery but her suit does not say at what point during her employment that occurred.

The lawsuit seeks \$500,000 for compensatory and punitive damages, along with an unspecified amount for mental anguish and emotional distress.

## FIRST TG CANDIDATE TO RUN IN JAPAN

(Tokyo) In a landmark decision a transgendered woman will be allowed to run for office in her corrected sex, even though under Japanese law she is still considered a male.

She will be listed on the ballot for Tokyo's municipal government under her chosen name of Aya Kamikawa. When Kamikawa, 35, presented her candidacy documents to an election administration committee she left blank the box for sex.

Local officials referred the question to the federal government, which ruled she could run as a female, but all official reports and records of the poll will refer to her as a man.

Kamikawa is on a hospital waiting list to undergo sex reassignment surgery later this year. But even after the surgery is complete she will continue to be officially recognized as male on her family register, the official document the government uses for all identification.

Japan is one of the few major industrialized nations which does not have transgender rights. The term transgender is not used. Rather, TGs are referred to as people "suffering gender identity disorder."

## B.C. Must Pay For Sex-Change Surgery

### HUMAN RIGHTS TRIBUNAL SAYS TRANSSEXUAL DISCRIMINATED AGAINST

A transsexual B.C. man is pleased that the B.C. Human Rights Tribunal has found the provincial government discriminated against him by refusing to pay the cost of completing his gender-reassignment surgery.

Tribunal member Judy Parrack ordered the health services ministry to pay almost \$30,000 for previous operations done in California, plus the cost of completing the surgery and \$6,500 compensation for injury to the dignity of the complainant, Louis Waters. Waters, 44, is a female-to-male transsexual who lives outside the Vancouver area with his wife and two adopted children. He is self-employed and has lived as a man since the early 1980s.

He estimates it will cost \$93,028 Cdn — in addition to the \$30,000 the government has already been ordered to pay — to complete his gender-reassignment surgery in California. Female-to-male surgery is not performed in B.C. The cost to be paid by government for the final stage of surgery is to be negotiated, Waters' Vancouver lawyer Allan McDonnell said Thursday. "He's very pleased," the lawyer said of his client, who declined an interview request. "He's actually spent more than \$100,000 Canadian so far." That includes flights to and from California, drugs, operations and post-operative care in California.

McDonnell said his client wanted to remain anonymous, but Waters filed his complaint to get proper compensation and hoped to set a precedent for other people seeking to have female-to-male surgery. "He didn't want anyone else to go through what he's gone through," McDonnell said.

Waters and his wife had to borrow heavily to pay for the first- and second-stage operations, he added. Waters wasn't able to complete the surgery because he couldn't afford it. He testified at the tribunal that once he started the process of gender reassignment, he realized there was "no going back" but never thought he would be left without a penis.

After participating in the required gender identity clinic program at the Clarke Institute of Psychiatry in Toronto, he was approved for gender-reassignment surgery, which involves a number of steps, including phalloplasty — the creation of a penis by plastic surgery. He went to California for the first and second stages of surgery, but the B.C. health ministry would only pay the physicians' fees at the rate as if the surgery had been performed in B.C., which was substantially less than the amount Waters paid.

Waters filed his complaint to the tribunal in 1997, alleging that the B.C. Medical Services Plan discriminated against him and denied him a service or

facility customarily available to the public because of his sex and sexual orientation, which contravened Section 8 of the Human Rights Code.

The tribunal found there was discrimination and ordered the health ministry to pay Waters \$29,749.21 Cdn for medical services already received, \$644 Cdn a day for the days Waters was at the Recovery Inn in California, \$1,000 for legal expenses incurred as a result of the contravention and \$6,500 for compensation for injury to Waters' dignity.

The government is reviewing the decision before deciding whether to appeal, said Tara Wilson, a public affairs officer with the ministry of health services. The tribunal was told that B.C. provides coverage for male-to-female reassignment surgery, but considers phalloplasty to be experimental surgery and does not provide coverage for female-to-male surgery not performed in B.C. This is not the case in Alberta, which provides coverage for phalloplasty (\$24,740), penile implant (\$8,095) and testicular implants (\$2,845).

Most provinces across Canada do not provide coverage for phalloplasty, although Quebec provides coverage in exceptional circumstances approved by the minister of health, and Newfoundland provides coverage on an individual approval basis if a candidate is assessed and recommended by the Clarke Institute.

The tribunal heard evidence that Waters had a difficult childhood and adolescence, including depression and two suicide attempts, one after he moved to B.C. in his late teens. Since he reported being uncomfortable with his body, doctors recommended reduction mammoplasty, which he had in Victoria in 1981, paid for by MSP. But the surgery didn't help, Waters testified. He felt he was a man, so he began living, dressing and working as a man. He changed his name in July 1985. In March 1988, he was issued a new birth certificate reflecting his sex as male. On June 18 of that year, he married.

When Waters was told that no surgeons were doing phalloplasty in B.C., he began looking in other provinces. Unable to find anyone doing the surgery in Canada, he contacted a California surgeon, who provided a quote of \$47,000 US for the required surgeries, provided were no complications.

He submitted the quote to MSP, which said in a March 1, 1995 letter that it would pay an estimated \$2,998. After consulting the California surgeon in July 1995, Waters received further, higher estimates, due to complications: \$29,200 US for the first stage of phalloplasty and \$37,650 US for the second stage. In September 1995, Waters had the first-stage surgery and testicular implants in California.

When Waters returned to Canada, his lawyer wrote to MSP seeking reimbursement of \$41,563 Cdn in medical expenses, which was only a portion of what Waters had paid. On Feb. 12, 1997, MSP said it would only pay for physician services up to B.C. rates. Waters said the restriction to medical services being paid at B.C. rates did not apply to him because phalloplasty was not being done in B.C., so he filed his human rights complaint.

## COURT DENIES TRANSGENDER CUSTODY

Illinois transgender advocates called a Cook County judge's decision April 8 denying custody of a child to a transgender man "unfair" and "sad." "It's sad that transgender people have to go through all of this," said Lorraine Sade-Baskerville, founder and director of transGenesis Social Services. "We are still invisible."

The case involved a couple, not identified by name to protect their child, who married in 1985. The husband reportedly did not disclose to the wife prior to their marriage that he was a transgendered man who had received hormone therapy but had not undergone surgery to alter the female genitals with which he was born.

The couple remained together even after that was disclosed and in 1992 had a son through artificial insemination. Both parents were listed on the insemination contract and birth certificate. The couple separated in 1998 and the child, who lives with his mother but has continued to spend time with his father, says he wants to live with his father. Cook County Public Guardian Patrick Murphy, who reviews custody disputes on behalf of the children involved, argued in court that the man is the better parent and the child loves him and wants to live with him.

But Cook County Circuit Court Judge Gerald Bender said the man's gender identity was relevant. The husband was a woman under Illinois law, Bender said, and since same-sex marriages are illegal in Illinois, the couple was never married and the father has no legal standing to seek custody. "The parties' purported marriage is invalid because the Legislature has determined that a marriage between two individuals of the same sex is prohibited in Illinois,"

Bender said. Bender nonetheless ordered continued regular visitation between the boy and his father.

Neither the father nor mother commented after the ruling but Murphy said he plans to appeal, arguing that the couple signed an insemination contract to have the child and raise him. Murphy said that contract and the boy's best interests should dictate the outcome of the case, not the issue of same-sex marriage. "We're disappointed," Murphy said. "It was a very complex case."

Catherine Sikora, a transgender advocate on the board of Equality Illinois, said American society and the legal system aren't keeping up with evolving family structures. "We'll see a lot more of these cases," said Sikora, a transgendered woman who is also a parent. "It's not as simple as this nuclear family, Donna Reed thing. When we go to parents' meetings at the school, there are gay parents, straight parents, single parents, transgender parents. The culture's changing and social institutions like the courts may not know exactly what to do."

Sikora noted female-to-male surgery is more difficult and less successful than male-to-female. Having surgery, she said, should not determine what gender a person adopts anymore than biology does. "That's an ancient model," Sikora said. "What if you say, 'I don't want to have surgery but I want to live this way.' Why shouldn't that be acceptable?"

Sikora said her daughter has no issues with her gender identity and expression—"She's blind to it." "It's terribly unfair for this man who's been raising this child," she said. "It's just not right."

Sade-Baskerville said the ruling highlights the need for legislators to remedy discrimination based on gender identity. "They can take our tax dollars," she said. "But we can't get married. We're still not recognized. Why should we have to beg for protection?"

## NTAC Applauds El Paso TG-Inclusive ERA

The National Transgender Advocacy Coalition (NTAC) applauds the El Paso City Council, which voted unanimously on Tuesday, April 9, to expand its anti-discrimination ordinance. The amended ordinance will ban discrimination based on sexual orientation or gender identity, which Rep. Sumrall described as "one's gender being misidentified at birth."

The city council set out to amend the ordinance to add "sexual orientation" to its protected categories in the nondiscrimination code after a city council representative mentioned that a grant the city was seeking required certain language protecting gay and lesbian citizens. She explained that a number of companies require a prohibition against sexual-orientation-based discrimination before they will provide grants or donations. Lisa Turner, a transgendered city council candidate, asked the council for the additional coverage of "gender identity. The council agreed, and the gender identity amendment faced no opposition.

The newly passed ordinance declares it unlawful to "refuse, deny or withhold from any person, for any reason directly or indirectly relating to the race, gender, gender identity, sexual orientation, color, religion, ethnic background or national origin of such person, any of the accommodations, advantages, facilities or services offered" to the general public.

"The fact that I have been attending city council meetings and participating in those meetings for the last two years made it easy for them to accept the gender identity addition," stated Turner, a steering committee member of the Texas Gender Advocacy & Information Network (TGAIN). "It was during this time that all council members and the Mayor got to know me," she added.

"This is what I believe allowed the gender identity provision to be added without opposition. Even my opponent for the District 8 seat on city council [Anthony Cobos] was for it and did an interview on TV saying [that] we cannot discriminate against the citizens of El Paso."

"Lisa has been a pleasure to know and work with," said Rep. Sumrall, who has visited with Turner often, since Turner's announced campaign for city council. "I felt this was the right time [election season] to put this on the agenda - it passed 8-0," she added.

"Let this ordinance serve as a reminder to everyone," said Rob Knight, president of El Paso's LAMBDA GLBT Community Services. "[that] we should focus not on differences but instead emphasize our common humanity." "We took a small but important step yesterday," said a modest Turner, preparing for her upcoming campaign in El Paso.

"NTAC celebrates the El Paso City Council for taking a courageous stand to make all El Pasoans equal," said Vanessa Edwards Foster, Chair of NTAC. "The ordinance victory with gender identity included was testament that equal consideration for all people is what resonates with Americans - even in archconservative Texas."

All three nondiscrimination ordinance votes in Texas since 2001 - Houston, Dallas and now El Paso - have included gender identity and passed with healthy support. Houston's ordinance only extends to city employees. "The El Paso City Council showed what leadership, vision and principle are all about," Foster added.

Underscoring El Paso's commitment to its citizens, Rep. Sumrall added that coverage for domestic partners on the city's insurance plan will begin in January 2004. "I am thrilled and honored to have been the one to lead the charge on this very important addition to our discrimination ordinance - at last, all members of our community have equal protection," said Rep. Sumrall about the ordinance victory.

"It was only the right thing to do."

## HAWAII HATE CRIME LAW TO COVER TGs

(Honolulu, Hawaii) By a vote of 39-8, the Hawaii House of Representatives has passed legislation adding "gender identity or expression" to the state's hate crimes law. The bill has already passed the Senate and Governor Linda Lingle is expected to sign it this week.

Hawaii's existing hate crimes law covers race, religion, disability, ethnicity, national origin and sexual orientation. Anyone convicted under the statute would automatically receive a longer sentence.

"The victory in Hawaii is a victory for the entire gay, lesbian, bisexual and transgender (GLBT) movement," said Lorri L. Jean, Executive Director of the National Gay and Lesbian Task Force. "It shows that legislators really do care about the rights of everyone in our community and that trans-inclusion does not hinder a bill's passage."

The NGLTF Transgender Civil Rights Project worked with state activists including "Civil Unions - Civil Rights Movement," the Hawaii GLBTQI advocacy organization which led efforts to pass the bill.

"Today, from the mainland we celebrate another victory for transgender people this legislative session," said Lisa Mottet, the National Gay and Lesbian Task Force's Transgender Civil Rights Project Legislative Lawyer. "This year may be the best year yet of passing transgender-specific and transgender-inclusive laws at the state level."

Earlier this session, the New Mexico legislature passed two transgender-inclusive bills, an anti-discrimination bill and a hate crimes bill, which now await signature from Governor Bill Richardson. Other transgender-inclusive bills are making progress in California, Illinois and Washington State.

Last year, Pennsylvania passed a transgender-inclusive hate crimes law and New Jersey passed a transgender-inclusive safe schools law. Also last year, fourteen local jurisdictions, with a total population of 18.4 million people, enacted anti-discrimination laws with transgender protections or added transgender protections to existing anti-discrimination laws.

## New Investigation Launched In Philly TG Murder

(Philadelphia, Pennsylvania) After months of inaction by Philadelphia police District Attorney Lynne M. Abraham has announced an investigation into the killing of a transgendered woman. Nizah Morris, 47, was found unconscious on a downtown street last December. She died of massive head injuries two days later in hospital.

Facts about the case have been hard to come by. What is known is that Morris had been picked up outside a local gay bar by a female police officer who said that the woman was drunk. She offered her a courtesy ride home but the officer said Morris wanted to get out of the car at a downtown intersection. She was found near death on the street a short while later by another officer.

Police ruled the death a homicide but gay community leaders say police have done little to solve the killing. Gay activists accused investigators of doing a sloppy job, while police have said they just have no clues and no witnesses.

Hundreds attended a vigil held in Morris' honor in January. Abraham's decision to open the case follows a series of hard hitting articles in Philadelphia Gay News. The paper asked why Morris was given a ride by cops, if she was not under arrest. They also reported that the officer who gave the ride did not file a police report. Another question that remains is just how drunk was Morris that night? Police have refused to release toxicology reports

Morris' mother, Roslyn Wilkins, said she hopes this new investigation reveals some answers. "Nizah was a human being and she was murdered," she said. "I am very anxious to find out what the investigation will bring." The problems surrounding the case have prompted the police to revive a committee designed to advise the police commissioner on lesbian, gay, bisexual and transgender issues.

## ARAUJO DEFENDANT SEEKING BAIL AGAIN

HAYWARD — The attorney for one of three men facing murder charges in the death of Eddie "Gwen" Araujo has filed a motion to get his client released on bail again.

Michael Magidson, who was released on \$1.68 million bail Feb. 7 but ordered back into custody March 18 after the conclusion of an eight-day preliminary hearing, is trying to get that order revoked. Michael Thorman, Magidson's attorney, filed the motion last week in Oakland Superior Court. Oral arguments are expected later this month.

Deputy District Attorney Chris Lamiero, who has been assigned to the case, said he hasn't seen the petition. "(I'm) not in position to comment," Lamiero said. "I'm not aware of the specific issues raised."

Meanwhile, Magidson, 22, of Fremont, and Newark residents Jose Merel, 23, and Jason Cazares, 22, pleaded not guilty Wednesday to murder charges that include a hate-crime enhancement. They were ordered last month to stand trial for the murder of Araujo, who was killed six months ago during a party at Merel's Newark home.

The transgender teen was punched, kicked, kneed, hit over the head with a can and a frying pan and beaten with a shovel after the three men discovered Araujo — also known as Lida — was biologically male.

"Everything went as expected (today)," Lamiero said. "There were no surprises."

A fourth man, Jaron Nabors — who turned 20 Wednesday — accepted a deal with prosecutors in exchange for his testimony at the preliminary hearing and during the upcoming trial. He has pleaded guilty to voluntary manslaughter and will serve 11 years in prison.

Magidson, Merel and Cazares are scheduled to return to court April 23 to discuss scheduling for any motions defense attorneys may want to file and possibly to discuss trial dates.

Lamiero wants the trial to start as soon as possible. "I would like to see it get out to trial within a year," he said. "The sooner the better."

The Superior Court judge in Oakland could deny the bail motion, or send it back to Superior Court Judge Mark Kenneth Burr for reconsideration. Burr ordered Magidson back into custody in March, calling him the "primary actor" in the killing.

Sylvia Guerrero, Araujo's mother, said everything is going as expected. The three were ordered to stand trial and Magidson is back in custody. Now she wants the trial to start soon. "The sooner the better so my family can begin to heal," she said.

## TRANSGENDER MURDER TRIAL WILL BE CLOSELY WATCHED, LAWYER SAYS

The trial of three men accused of killing a transgender teen in a fit of rage moved closer Wednesday when the defendants pleaded innocent to murder charges.

A judge found probable cause for the three men to stand trial last month, leading to their arraignment Wednesday. Trial could start nine months to a year from now, said Gloria Allred, attorney for the victim's family.

The case arises from the Oct. 4 killing of Eddie "Gwen" Araujo, a 17-year-old who was born male but lived as a woman. The killing took place after Araujo's biological identity was unmasked at a party at the home of Jose Antonio Merel, 23, in Newark, a San Francisco suburb.

According to testimony at a preliminary hearing last month, Araujo was slapped, choked, beaten with a skillet, tied up and strangled in an attack that lasted for about two hours. Her body was driven to the Sierra foothills about 150 miles east and buried in a shallow grave.

Attorneys for the three men argued that they were carried away by passion after finding out that the beautiful girl they knew as Lida was a man. Two of the defendants had had sex with the teenager believing her to be a girl, according to court testimony. It was after those encounters that suspicions arose about Araujo's gender, leading to the Oct. 4 confrontation, witnesses said. However, a judge rejected those arguments.

Merel, along with 22-year-olds Jason Michael Cazares and Michael William Magidson all face charges of murder in a hate crime. A fourth man, Jaron Chase Nabors, 20, was also charged in the murder but struck a deal to plead guilty to voluntary manslaughter in return for testifying against his friends.

Once the trial starts, it likely will be closely followed, Allred said. "Many transgender youths are in the closet. They live in fear. They are persecuted. They are humiliated. They are the victims of discriminatory acts and sometimes of violence," she said. "So there will be many people in this country who are looking at this case and are hoping for justice in this case."

Sylvia Guerrero, Araujo's mother, said she is ready for the trial to begin.

## PERFORMANCE BENEFITS THE ARAUJO FAMILY

NEWARK — Six months after the slaying of Eddie "Gwen" Araujo, the transgender teen's family is struggling not only emotionally but financially. "It's an ongoing (financial) problem, but through the grace of God we're making it," said Sylvia Guerrero, Araujo's mother. "We're not starving, but we're not rolling in money either."

Guerrero, 39, still hasn't gone back to work and is relying on charities, donations and disability checks to pay rent and bills. Meanwhile, students at Newark Memorial High School are doing what they can to ease the pain.

On Friday night, a cast of about 10 performed a talent show featuring nearly 40 songs, dances and poetry acts to raise money for the Eddie "Gwen" Araujo Fund that benefits the family. Titled "One night ... One reason: Gwen," the show is intended to raise money, but it may also help assuage some of the mental anguish the family has suffered.

Anxiety and post-traumatic stress have caused Guerrero to miss work, she said. She and her two sons are undergoing therapy. The boys, 14 and 11, seem to be doing reasonably well, considering the circumstances, she said.

"I don't know how they do it," she said. "I'm having a hard time." On Friday, performers will begin the 8 p.m. show with a hip-hop song and dance that attempts to capture a "heavenly feeling," said Weldon "B.J." Hatter, the 1998 Newark Memorial graduate who is organizing the event.

Choreographed by students Victor Cruz, Kate Lyness and Marcy Shaw, the song entitled "My Pain" captures the silver lining of the tragedy, he said.

"During a break in the song, (they sing), 'From the bottom of my soul on the feeling of loneliness, I come down to earth,'" he said. "We feel it's Gwen telling us she's coming down." The show may provide Guerrero's family an emotional break from the stresses of recent developments in the case.

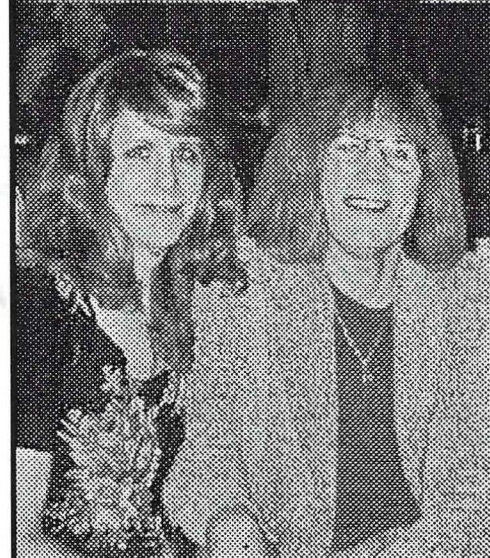
Last month, three men were ordered to stand trial on charges of murder and a hate-crime enhancement when a judge ruled there was probable cause to believe they killed Araujo — also known as Lida — after discovering the teen was biologically male. Michael Magidson, 22, of Fremont, and Newark residents Jason Cazares, 22, and Jose Merel, 23, have pleaded not guilty. A fourth man, Jaron Nabors, 20, pleaded guilty in March to voluntary manslaughter in exchange for his testimony against his three friends. Nabors will be sentenced in May to a maximum of 11 years in state prison.

Araujo's death has altered the family members' lives in every way, Guerrero said. The once-avid movie-goers haven't been to the theater since the killing, she said. "We used to go camping all the time," said Guerrero, who is on disability through May 5. "I don't think I'll be able to do that for a long time."

Araujo's body was found in a shallow grave in the Silverfork Campground east of Placerville. "It's like everything's at a standstill and the pain in my heart hasn't left," she said. "This was my child taken from me and it still hurts." Hatter said he wants to do everything he can to help.

"The family is going through so much right now... we want something positive," he said. "We want Gwen to be remembered."
