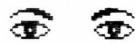

Public Restrooms

As promised last issue, what follows are my thoughts on tending to one of life's most basic needs. Having only been out in public since the Be-All last May, I do not claim to be an expert, but I have observed the surroundings and have had the opportunity to use many womens' restrooms since then.

In general, when you are going out, go to the potty before you leave home and limit your intake of fluids while out. Many fast food restaurants offer the opportunity to use their facilities, but look for those where the volume of traffic is light, and try to avoid those where large groups of children and teens congregate, such as *McDonald's*. Except at peak food serving times, you should be able to go at almost any fast food location without sharing the bathroom with someone else.

A few good places include *Hardee's*, *Gold Star Chili*, *Frisch's*, *KFC*, *Long John Silver*, *Burger King*, *Arby's*, *Captain D's*, *Taco Bell* and *White Castle*. I'm sure there are others, but my observations indicate that these places are usually safe and, except at very busy times, any of the above would be a good choice. Some, but not many, fast food establishments provide restrooms which can be locked. It would not hurt to scout out a few locations in areas where you normally eat and shop.

Shopping malls can present a problem, but usually one can sit in the food court near the restrooms and watch for a time when the facility is not being used. Many malls have multiple restrooms and at least one of them will be in a low usage area.

Most gasoline service stations have a single person facility which can be accessed quite easily, even though many require a key. Simply ask for the key and use whichever door the key fits.

Many businesses are going to a Unisex approach because of cost factors involved in providing separate facilities (which is good for all of us). Quite a few discount department stores, not situated in a mall, have restrooms which are open to the public and see minimal use.

Some places with high traffic volume, such as airports and bus stations, which at first glance one might tend to avoid, can be utilized, because most people there are in a hurry and are inclined to get in and out rather quickly. Another spot to consider would be any of the motel chains, which usually have public restrooms just off the lobby.

Almost any restaurant with patron seating would be a good candidate for a relief stop, as would most public libraries. Many churches which are open during the day have public facilities.

On the road again!

Most of the above suggestions also apply while traveling. My gut feeling would be to avoid rest areas along the interstates, as well as truck stops. Some general advice. When the need arises to 'inspect the plumbing', it is generally best to head right for the restroom before making contact with anyone in the establishment, except in those cases where you need a key. The fewer people who have a chance to look you over, the better.

Act as if you belong there and walk right in without hesitation. If the restroom is crowded, you can always turn around and leave. If people come in while you are in a stall, simply wait until they leave. Sit down if possible, but always remember to lower the seat and **never** stand facing the toilet. Do not linger in the powder room.

If a situation arises where someone should challenge you, I would suggest an attitude of humility. Explain that you are only there to relieve yourself and hope that they will understand that it is more prudent to use the women's restroom dressed as you are. If they are still upset, apologize and leave quickly.

With experience in the real world, you will eventually acquire a knack of knowing where to go and which places to avoid. I hope that a few of my thoughts will be of assistance to you in the future.

Last, but not least, carry a portable potty in your car for those times when nothing else seems feasible.

The Other Woman

In treating couples that include a transgendered person, therapists often overlook the experience of the non-transgendered partner. In doing so, they miss 50 percent of the entire transgender experience, as well as a critical opportunity to help these couples move forward. How and at what point in the relationship a female partner learns of her

husband/boyfriend's transgender identity is critical. When the female partner learns of the transgender issues during courtship, the prospects for the development of a healthy long-term relationship increase because nothing is hidden.

However, finding out about transgender issues once the relationship has been established can be traumatic. For example, a transgendered man may be reluctant to reveal his identity because of fear that his partner, whom he loves, will leave him. But, like a person having an affair, he may leave clues around in hopes of being discovered.

Coming upon a bag of clothing tucked behind a drawer or a matchbook from a transgender bar can trigger feelings of cataclysmic anxiety in the female partner. Once the secret is revealed, she may be overcome with revulsion. Her partner's transgender identity seldom matches the image of a committed relationship that she learned growing up.

If the female partner comes from an abusive, alcoholic or otherwise dysfunctional family, finding out about transgender identity in this way can trigger familiar feelings of betrayal. Her trust in her partner may be shattered, and she's likely to ask: "What else don't I know?"

The female partner may feel: "I thought I knew you. I'm sharing my life with you. I'm having your children. And this is even worse than an affair, because I can't compete with this."

(Cole) has observed two basic trends in women who begin to integrate their partners' transgender identities. The first is to become "the best transgender partner ever." Once the shock of revelation is past, these women sign up. They attend meetings and assume leadership roles in the transgender community, help their partners choose clothing, and may join their partners in "dressing alike."

The other major trend is for the female partner to "neuter" herself. She may stop doing her own grooming and feel very threatened by her own femininity. When she comes upon this avalanche of discoveries reflecting that her husband has a very strong feminine side, she can feel confronted with her own fear that she is not feminine enough.

If she remains in the relationship - as most female partners do - she needs to be allowed to assimilate this knowledge at her own pace. Often female partners may feel rushed to participate in the community before they are ready to do so.

Once the woman accepts that transgender issues are in her life, she begins "the management syndrome." Because of female socialization, women tend to be the primary caretakers in families. They are often much more concerned than their partners are about the risks of discovery. A female partner typically takes charge of who is to know about the transgender identity, how they are to find out, and when. In conservative

communities, female partners risk losing their entire support network if the secret gets out.

When surveyed about what it's like to be the wife or girlfriend of a cross-dresser, women answer to please. They give the best possible answer to every question, asserting that "Everything is just fine." But underneath that positive attitude lies a lot of turmoil, much of which comes from the burden of managing the secret.

The stress of managing the secret may cause women to lose track of their own struggles. Many couples collapse after years of functioning relatively harmoniously. Though no one has studied this trend, (Cole) hypothesizes that the woman's years of managing the secret may cause her to lose focus on her own feelings and needs. As she enters into the normal aging transitions of peri-menopause, suddenly she may become acutely aware that she needs some nurturing and attention herself. She may become impatient, blaming or negative as a result.

When such a couple comes in for treatment, the risk is that the therapist will focus on the transgenderism to the exclusion of the female's partner's issues. In fact, usually the partner has been dealing with transgender identity issues for most of his/her life. For the wife or girlfriend, on the other hand, this is a new experience and one that she has not been socialized to handle.

Unless we address her life experiences and expectations, we're never going to understand the impact that the revelation of transgenderism has on her. As therapists, we need to keep a healthy perspective and not make the transgender issue bigger than it needs to be, while dealing explicitly with how it affects the individuals involved.

A therapist should work to help the female partner get the mosaic of her expectations together so that the couple can go forward. When that occurs, the relationship can become extremely strong.

Some women find themselves not only surprised and anxious, but also intrigued by the feminine side of their partners. A woman may be surprised by the way that her partner is more communicative en femme.

The female partner may discover that the feminine side of her partner arouses some same-sex interest in herself. This doesn't mean that she's "bi-sexual" or a "lesbian" or any of the other labels that produce fear and anxiety. Instead it's an opportunity for her to start on her own gender journey.

When partners trigger the whole spectrum of gender in each other, they can explore that spectrum together in a non-shameful way. Her masculinity can arouse his femininity; his masculinity can arouse her femininity, and so on. Once there's nothing hidden, these couples can become amazingly strong. Each partner can be unconditionally respectful of the whole of each other. And as they explore the entire spectrum of their gender identities together, the resulting symbiosis is very erotic.

Because they do a background check (including fingerprints), I felt compelled to tell the two people I work for of my past, before they discovered it. I guess times are changing. Each responded identically with a "So?" I can only conclude that

by not being stereotypical and working hard at the position before they were aware of my status, I managed to convince them it was not an issue. This does not mean I am "out" at work, there are 70 people in the immediate department and probably 1000 in the building who are not clued in. My goal is to keep it that way. Does this mean I am turning into a "stealth" transsexual? Not a chance. I just know there are areas of my life where I am better off if people don't know my past.



So here I am, picking my "spots" again. Last month I had the distinct honor of being appointed to the *Stonewall Cincinnati* board of directors. This is good! Because we really are in this together, adding **our** voice to that of the gay/lesbian community will not hurt us. My goal as a transgendered member of the board will be to have the mission statement amended to include us. Although it is not policy, *Stonewall* has unofficially supported trans-inclusion and several other members of the board are openly supportive of that concept. But this being politics, we need to be sure we are openly supportive of issues affecting those in the gay/lesbian/bi community. Active involvement in each others' organizations is the best way to destroy the stereotyping that has separated us.

Some of the other organizations which accept transgendered members are: the *Metropolitan Community Church* (MCC), the *Queen City Careers Association* (QCCA), the *Gay and Lesbian Community Center* and the *Log Cabin Club*. If you are a cross-dresser, not all functions these organizations have would be appropriate to "dress" for. However, when it is time to try again on a Human Rights Ordinance, we will need their support in order to be included.

One of the events for which "dressing" **was** appropriate was the *Community Center* Christmas Party. *CrossPort* provided the best dressed contingent (excluding me, of course). We mingled with members of the gay/lesbian community and made friends for the future. What a concept!!



An all inclusive "queer" organization at the University of California - Northridge came up with a name that Phyllis Frye has latched on to: "Lesbigaytrs" (rhymes with alligators). Perhaps we ought to be promoting **that** concept also!

They are very attractive and a definite upgrade from the address label name badges we've been using.

If you are interested in having one of these made for you, the cost is \$10 and you can send your order and money to the PO Box. Make sure you spell out your name **exactly** how you would like it written. I would prefer that everyone has a last name printed on the badge - real or fictitious. I will be placing the next order on January 15, so any requests I have by that time will be ready for me to bring to the Thursday meeting.



I spoke with Roger Naylor this evening. Some of you will recall he is the writer I arranged to have tell the story of the Be All convention. The article was supposed to be printed in *Cincinnati Magazine* but due to a series of editor and publisher changes, it didn't make their cut. Events include: dinner with Virginia at the CN Tower on Friday night, an all day party and buffet on Saturday and JoAnn and Virginia co-hosting a show at Tallulah's Cabaret on Sunday evening.
