FOLLOW-UP ON DISCRIMINATION CHARGE

I have worked for the State of Georgia since November 1, 1970. The past eleven and one-half years, I have had current position. January of 1994, a new position was created in the unit I work in. I knew the position was being created; I sent my application to the State Merit System to be graded. I received a score of 98. When the job was announced, I submitted my application. Five applications (including mine) were received.

The position was advertised again. I wrote a note to the Unit Chief to withdraw my application. When my co-workers learned that I had done so, they insisted that I retrieve the note before the Unit Chief saw it. They told me "there was no way that they can not give you that job". They were so insistent that I get the note back that they convinced me that I should not withdraw my application. (At this point they wish they had kept their mouth shut.) The number of applicants increased to fifteen with the second advertisement. Only three of the applicants, including mine were certified.

The position was advertised for the third time. By this time I wish I had never heard of the position, but my co-workers continued to encourage me.

When the interviews were held, my Unit Chief and a Unit Chief from another section did the interviewing. I asked the chief from the other section if she had read my application, her answer "No, I have not". I was already sure that I was not being considered for the position. Her response certainly did nothing to change my mind.

When this job was announced, the Section Director was "Acting" Section Director. Because of reorganization, there was nothing else available for him; he has since been named Section Director (no longer acting). The Unit Chief had been a Deputy County Director; because of some problems, he was removed from that position and brought to the State Office as a Unit chief.

The person hired for the position I applied for had not worked for over a year and as it turns out has connections with the Section Director - his sister-in-law and the Section Director's wife are good friends.

Dear Sir or Madam;

I need your help badly. I am a transsexual. All my life I have been living a life of Hell. I have suffered so much. I have gone to a few psychiatrists and they all agree that I am right in what I want to do, but none of them know where to go to get anything done about it. The psychiatrist that I am going to now finally found your address and advised me to write to you.

All my life I have been trying to get this mistake of nature corrected with no luck. I am now 53 years old and feel that I have wasted my life in the wrong sex. I need to live the rest of my life as a woman, what time I have left. I just can't go on like this, depression is so bad. I can't do anything, all I can think about is changing to be a complete woman or SUICIDE! I am afraid that if I don't find someone to help me soon, suicide will win out, I think about it all the time. I just can't take life like any more. PLEASE HELP ME! If you could please tell me someone here in Arizona, or the closest place to AZ. that I could go and see about this; I need help very quickly if I am going to survive this.

Please help me soon; tell me what to do and where to go to get the help I need so badly. I don't know how much longer I can go on like this. Tina

Dear Tina;

Your letter sounds like many letters I wrote throughout the fifties and sixties. It took me sixteen years to get help. Fortunately, I had my surgery when I was 29 years old, but like you I thought most of my life was over or at least what should have been the best years; but that's not the way it worked out. I have been very happy and I hope you will find that same happiness.

Under separate cover, I am sending you the name of a doctor in Arizona and also a copy of my book. Hopefully, it will help you in some way.

Good luck and let us know of your progress.

I first filed the complaint May 31, 1994 in the Division that I am employed. Nothing was done about it; I carried it to the next step. Still nothing was done about it. I sent my complaint to the Equal Employment Opportunity Commission. They acknowledged receipt of my complaint and then I heard nothing more from them. About two months ago I decided to contact them one more time. I received a call from the Intake Coordinator. He told me that my complaint had been assigned to someone who no longer worked for them and that my file had been filed away with nothing being done about it. He apologized and has since reassigned it to someone else. I spoke with this person last week. He advised me that they have a tremendous backload of cases; they are still working on 1994 cases. I have five and one-half years left to work before I can retire. I certainly hope this is resolved before that time.

I'm sure that those involved thought that I would give up if they ignored my complaint long enough.

In the meantime, I have ben transferred to another unit with the promise of an upgrade. It supposedly does not have anything to do with my complaint (I suspect that it does). I will continue to do the same work with new assignments, some of which I have been doing since June of 1994. They have not written my new job description yet but it is supposed to be retroactive back to April 1st of this year.

I will continue with my complaint until it is resolved. If I drop it I might have the protection I would have if I continue with it.

I have the support of many of my co-workers; that may change when it gets down to the nitty-gritty. People will offer all kinds of encouragement as long as it doesn't involve them.

I will keep you posted.

At this time I am pre-op, but very much have a yearning to become post-op. All the information you can send me will be greatly appreciated. I need to be pointed in a safe, and not financially out of reach direction.

I have no medical insurance so all my expense is out of my own pocket. I also am living with and engaged to a woman with a four year old daughter who calls my dat. So, any information is important to all of us so we can come closer to becoming a family. Also any information that can help them with dealing with any questions and social issues about my lifestyle would be helpful. We are open to any comments, ideas or suggestions. Cory.

Dear Phoebe;

I am about to complete my physical transition (Hooray!). My surgery date with Doctor Seghers is April 19, 1995. Even after surgery I will continue to grow and have questions. These questions will make my life, needless to say, interesting and insightful, not only because of being a transgendered person, but because of being very human and realizing the needs of people.

For me, finally getting my physical body to match my mental feelings is just a beginning. I feel as though I need, and want, to be as complete as possible. There are a lot of questions that need to be asked. Questions that your readership might probably be interested in.

My career, before my transition was based in broadcast journalism and video production. I thought what an interesting concept to make a "video magazine" based on the combination formats, in video style, of your newsletter and the "Tapestry". Do you believe that your subscribers would support and be interested in such a concept?

We are talking about a start-up date of no sooner than this fall, but it could and would cover a more in-depth view of not only the transgender life, but survival. As we all know, going through transition is no picnic, and if we could offer guidelines and a support system through the video market place, it might make it easier for each individual and those who are not transgenders (family members, friends, etc.) to get through.

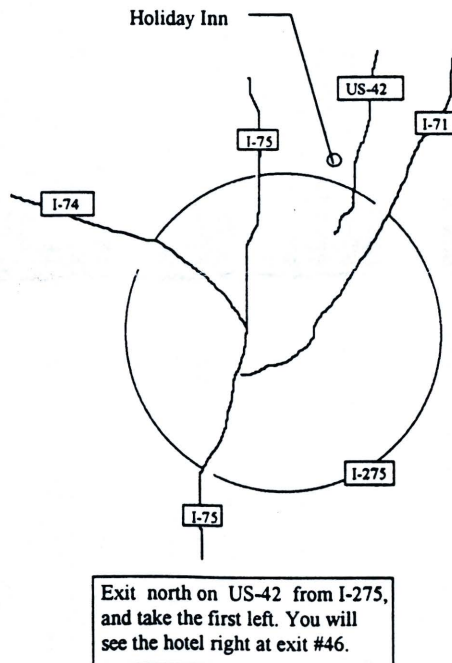
